8 The Director of Collections report was given by Pat Loven. She reported that on October 3, 2023, Tracy Pounders, Delinquent Attorney, for the City of Paris, held a tax sale with fifty vacant lots offered for auction. Twenty-one lots sold for a total of \$27,070.00. She also advised that Linebarger, Goggan, Blair & Sampson, LLP are preparing for a sale in December.

She reported the collections for the month of September were a total of \$285,311.08. She advised that tax statements would be mailed as soon as possible, after the November 7th election.

9 The Director of Operations report was given by Sue Shelton. She reported the tax rates have all been received and preparations have been made to generate the tax bills as soon as the election is over. She advised the Mortgage company imports and collection only information from Fannin and Delta Counties, has been completed.

She reported the Ag Board meeting was held on October 3rd. James (Jimmy) West was unable to attend due to a medical concern. The Agricultural Surveys were completed and Johnny Patterson went over programs. Concerns were raised at the number of acres that have changed from cropland to commercial for the solar farms. Hugh Jones stated that Deodar Weevil, better known as eastern pine weevil, is attacking the destressed pine trees and several have been lost. Hugh Jones stated that he will not serve on the board next year. Tammy Moss is willing to continue. Johnny Patterson said he may be retired next year, but did not say he was resigning. It was mentioned that Katy Reese would be a good replacement for Hugh Jones.

She advised that the school district property value study information has been turned in to the state and the preliminary MAP information has also been completed. She reported the Appraisers are continuing their education with Dorcas Driggers and Candi Nabors completing USPAP & Appraisal of real property. They are enrolled in Income classes on November 13th. They attended the State Laws and Rules update on September 20th.

She said the maps of Prairialnd and Chisum are coming together as a group effort between Harris Govern, CAMA Cloud and BIS and the appraisers are out in the field again.

She spoke with the boys step-father, he apologized and explained the young boys disabilities, and told her that they no longer live in the apartments, but were there visiting.

She asked the Board that on future Delinquent Tax Sales, the "Bidders" will now have to sign a letter stating that they do not owe any delinquent taxes in Lamar County, before they will be eligible to bid on properties. A letter will be composed prior to the next sale. She reported that the election of Board members will be done next month and that the Maps Review and Target Map Review is in progress. She feels very confident that we will pass both.

She told the Board that we are in the process of having a keyless entry installed on the back door.
