Heavy equipment, manufacturing, and processing equipment. Trucks and Trailers with apportioned tags may require a special form that you may acquire at the appraisal district for additional deduction.

10 YEAR LIFE-

Furniture & Fixtures, Office or Store Equipment, Data Equipment, Electronics and Machinery & Passenger Vehicles, Trailers
 Any Type of office furniture, retail fixtures, restaurant equipment, apartment and hotel goods and similar property.
 Building/contractor small equipment, automotive industry tools, fast food equipment and electric powered office machines.
 Communication Equipment fax machines, copy machines, point of sale equipment, and alarm systems.

6 YEAR LIFE-

Passenger Vehicles

List all owned vehicles used in the business. Vehicles disposed of after January 1 are taxable for the year and must be reported.

3YEAR LIFE-

Computers

Mainframe, servers, and personal computers.
